Godavari District, have been covered under Digital Class Rooms project with the
contribution of Hon'ble ZP Chairman, West Godavari, Eluru, Collector & District
Magistrate, West Godavari as well as with the donations received from the NRI's,
NGOs and local donors. Further the Govt of A.P has been providing the DCR's with
U-Sky content free of cost in the state

It is noticed that certain Headmasters of the DCR's working in ZP/Govt/MPP
/Municipalicty Managements have not utilized the DCR's content and observed less
usage from the DCR's for the Academic year 2018-19 till day and also not updated
the same in CM Dash board. The concerned Headmasters have failed to
implement the project which shows gross negligence towards their legitimate duite
as the project is prestisously being implemented by the Government . The
Collector and District Magistrate West Godavari Eluru, is directly monitoring the
DCR's usage in the district during weekly review meetings with the authorities

It shows gross negligence of **concerned DCR's Headmasters list annexed to
this notice** for not implementing the DCR's project which is highly irregular
towards their duties and hence she/he is hereby instructed to submit her
explanation with show cause as to why disciplinary action should not be ~~initiated~~ *initiated*
against the individuals under Rule 9 of A.P Civil services CC&A Rules 1991 for the
above said lapses , and irregularity within 04 days to the undersigned from the date
of receipt of this notice. Other wise, disciplinary action will be taken against the
individuals basing on the material available in this office as per A P.C.C .A Rules
1991. Receipt of this memo should be acknowledged.
